Doug Rauch: Attorney for M&T Bank joined to the meeting to provide some background on the \$340,000 debt the Borough will be looking to take out to work on capital projects. Projects include the lake dredging, Borough Hall repairs and Fire Hall remediation. Mr. Rauch explained the process of filing paper work with DECD in order to secure the funding. Provided the last five years of financial records in order for the Borough to show it can cover the cost of the loan. Will help the Borough with all closing and legal documents related to this loan.

Dane Collins: Asked Mr. Rauch if there is a specific need to establish a sinking fund specifically to fund this debt. Mr. Rauch explained that there is overlapping debt that we have in which this funding will be consolidated with after the first year.

Len Pinto: What is the catch with this funding. Mr. Rauch explained that this funding is common of local governments and with interest rates the way they are this is the best case scenario for the Borough if we are looking to work on capital projects.

Sue Borchet: What would we have to change what we are using the money for in the agreements? Mr. Rauch explained it would be a simple resolution by Council redesignating the funds for other capital projects.
