## APPLICATION FOR PERMIT TO PRUNE OR REMOVE SHADE TREE

## Ordinance 1043A: Shade Tree Ordinance

A permit shall be required to cut down a shade tree or to do major pruning to a shade tree along the streets in the Borough other than the minimum to meet clearance requirements over streets and sidewalks. Major pruning is defined as any tree work that reduces the crown; changes the outline or the cutting of a limb greater than 3 inches in diameter. All tree stumps must be removed to minimum 4 inches below grade. All contractors must be registered with the Borough before starting the job. The fee for a Permit issued is \$5.00. (no fee for permit denied). The Shade Tree Commission (STC) must review all Applications. The right to appeal any decision of the STC must be presented to the STC within 30 days of disapproval. The STC will review and make recommendations to Borough Council for decision.

PLEASE BE AWARE:

Ridley Park Ordinance #1043 enacted June 09, 1992

- TOPPING TREES IS <u>PROHIBITED</u>
- CLIMBING WITH SPURS IS PROHIBITED
- CUTTING OR DAMAGING LATERAL SUPPORT ROOTS SUCH AS DURINGSIDEWALK REPAIR IS <u>STRICTLY PROHIBITED</u>
- REMOVING A TREE OR PRUNING A TREE IS BY PERMIT ONLY

APPLICATIONS MUST BE REVIEWED BY THE SHADE TREE COMMISSION AND A PERMIT ISSUED PRIOR TO WORK PERFORMED ON A PUBLIC TREE.

Thank you for your cooperation. Shade Tree Commission Meetings are held on the second Monday of each Month at 7PM in Borough Hall, second floor, and are open to the Public.
