The first is a car that is parked on the street that leaks oil routinely. The owner lives in an apartment across the street, he has to put oil in his car everyday to drive. There are also tire tracks pulling oil through town. There is kitty litter on the oil. Mrs. Panek and other neighbors care about the neighborhood. She is wondering if there is a code for this, what is the process? Tutak stated that this is an illegal discharge and asked that Mrs. Panek meet with him after the meeting.

The second issue is the corner of Russell and Morton there is a stop sign that needs to be replaced, it is faded. There has also been an accident there. Maybe a sign that states cross traffic doesn't stop.

M. McGinley apologized stating he thought this was temporary, but stated that this will be rectified soon.
