

**BOROUGH OF RIDLEY PARK  
DELAWARE COUNTY, PENNSYLVANIA**

**Ordinance 2023-5**

**BE IT ORDAINED AND ENACTED**, by the Borough Council of the Borough of Ridley Park as follows:

**Section 1: Amendment of § 202-1 to codify Parking Meter Fees and Extend Parking Meter Hours.** § 202-1 of the Code of the Borough of Ridley Park is hereby amended to read as follows:

§ 202-1. Deposit of payment in meter or kiosk; overtime parking prohibited; extending parking time prohibited.

A. When any vehicle shall be parked in any parking space adjacent to which a parking meter or parking zone is located during the time of limited parking, the owner or operator shall, upon entering the said parking space, immediately deposit or cause to be deposited in said meter or digital platform, in all parking meter zones and municipal parking areas, such payment as is hereinafter required. Payment may be in form of quarters or smart phone app, as the Borough Council may establish from time to time and provide for in writing at such parking meter or kiosk. Failure to make such payment shall constitute a violation of this article. Upon the deposit or making of such payment, the parking space may be lawfully occupied by such vehicle during the period of parking time prescribed herein for the particular amount deposited.

B. To the extent that payment is made by means that results in an administrative charge, such administrative charge shall be paid in addition to the parking fees set forth herein.

C. The Council may, by motion, order the installation of parking meters or adjust parking zones to receive payment for increments of time in half hour or less and not in an aggregate amount in excess of the maximum parking times applicable for such respective Parking Zones.

D. Payment may be made via physical meter with physical tender or digital platform the Borough of Ridley Park is contracted for parking enforcement.

E. Parking Zones:

(1) Business District Spaces: Location: Unit Block of E Hinckley Ave, Unit , 100 Block of Sellers Avenue, Unit Block of Dutton Ave. These meters will be limited to 3 Hour Parking with payment \$0.75 an hour in this location. Hours of enforcement will be

from 9AM-9PM Monday through Saturday. No Parking Permits are eligible for this location.

(2) Train Station Parking Spaces: Location 100 Block of E Ridley Avenue, 200 Block of E Hinckley Avenue and Crum Lynn Station Meters. These meters will be eligible for extended parking from 9AM-9PM \$0.50 an hour in this location. This location will be eligible for “Train Station Parking Permits”. The cost for this permit will be \$90 per 6 months. There will be no overnight parking in these locations.

(3) Veterans Park Parking Spaces: Location Unit Block of E Ridley. These meters will be eligible for extended parking from 9AM-9PM \$0.50 an hour in this location. This location will be eligible for “Business District Parking”. The cost for this permit will be \$90 per 6 months. There will be no overnight parking in these locations.

(4) Hospital Park Parking Spaces: Location Unit Block of Bartol Ave, Morton Ave These meters will be eligible for extended parking from 9AM-9PM \$0.50 an hour in this location. This location will be eligible for “Business District Parking”. The cost for this permit will be \$180 per 6 months. There will be no overnight parking in these locations.

**Section 2: Severability:** The provisions of this Ordinance are severable, and if any sections, sentences, clauses, parts or provisions thereof shall be held illegal, invalid or unconstitutional by any Court of competent jurisdiction, such decision of the Court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted as if such illegal, invalid or unconstitutional, sections, sentences, clauses, parts or provisions had not been included therein.

**Section 3: Saving Provision:** Nothing in this Ordinance, as hereby amended, shall be construed to affect any suit or proceeding in any Court, and rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under this Ordinance prior to the adoption of this amendment.

**Section 4: Effective Date:** This Ordinance shall take effect and be in force from and after August, 31, 2023
