Below is the fire activity report for September 2023:

- 24 calls for the month:
 - o 4 building fires
 - o 1 assist EMS
 - o 1 natural gas leak
 - o 1 PECO wires
 - o 2 accident clean-ups
 - o 4 fire alarms
 - o 11 cancelled calls
- Total hours in service 9 hours 20 minutes
- Total staff hours 43.02
- Cumulative firefighters responding 79.

Other Activities:

- Fall Festival Chief Eckenrode stated-While not acknowledged, the Fire Company had 9 members provide approximately 8 hours of fire and medical coverage during the event. We also had a truck on display and had recruitment and fire prevention discussions with anyone who visited us. As previously discussed, we were forced to sell soda and water on the firehouse ramp and, despite the organizers' attempt to have the Health Inspector shut us down, we were still able to make a small profit. Fire Prevention
 - O Hosted or visited 426 students from St. James, Lakeview and RP Presbyterian Nursery School during multiple sessions on different days throughout the week. This takes a tremendous amount of time and money to prepare or purchase the various supplies that are given to the children. It should be noted that several members take vacation time or rearrange their work schedules to provide this instruction.
 - O Topics covered are good fires versus bad fires, stop, drop, and roll, crawling low through smoke, and get out, stay out. Because children in emergency situations are often scared of firefighters in full gear and SCBA to the point of running away and hiding, we have a firefighter put everything on in front of the children then go around to "fist bump"
 - Assisted Norwood and Prospect Park Fire Companies with their Fire Prevention open houses by providing fire extinguisher training and instructor for the Fire Prevention trailer.
 - Hosted our own Open House which, despite the rain, was attended by over 100 people. Thanks to Norwood and Prospect Park Fire Companies for returning the favor and assisting us.
 - Lastly, special thanks to Deputy Chief Brian Gilmore and Assistant Chief Karen Donkin for continuing to organize these events on behalf of the Fire Company.

Councilor Dalessio asked how many members attend each call, Chief said it all depends on but roughly 4.5.

Council Business

Recreation Board- David Valentin, Co-chair of Recreation Board gave a brief report. Drinks at the Lake- pre-Victorian fair event, held the evening before, was well-attended. The Victorian Fair had 80 vendors inquired but had to stop at 40 vendors due to space. The paddle boats were on the water the entire time. Special acknowledgement to Shawn Conran of the Rec. Board for saving a senior citizen who was at risk for falling into lake. Thank you to Borough Manager Tutak for repairing the boats and to Councilor Guerra for helping putting them in the lake.

Huge thanks to the Library for the 3 movies nights they were able to host.

M. Dalessio- Situation at the lake where a resident found graffiti on a memorial bench at the lake. The Borough was great about getting it cleaned up ASAP. If you see something happening around time, say something. These benches are memorials for family members.

Public Comment

Jason Flynn 40 Hetzel-

Has a problem with his neighbor next door, there is trash everywhere. He has gone to the Borough and the police department, and nothing is getting done. The neighbor is an issue and causing an issue with his children. Yesterday he called the Borough about him dumping waste outside. He said the Health Department was there but did not look. The Borough isn't doing anything about this property. Mr. Tutak, I spoke with you on the 25th of September, why haven't I heard from you? Why am I getting a fine for putting a fence in but he can have trash down the side of his driveway? L. Pinto asked to meet with him after the meeting. This neighbor dumps his trash in Hetzel Park. Tutak, can you give me an answer? President Collins said this individual has been cited and the case has not been heard yet. He received a citation for cutting a tree down in 2021 and hasn't been heard in court yet. He continues to be put off court.

President Collins said he has experience with this. We can cite and cite but we cannot force the courts to hear cases. The judge is not hearing other cases as quickly, including President Collins'. The current judge is near retirement, and we expect whoever is elected will move the cases.

Chief of Police said they are working with mental health resources to get him tested. The police department's hands are tied.

Borough Manager Tutak, this issue has caused legal issues in the past. We cannot go onto properties and take items.

When he met with Mr. Flynn, he brought the issue to the police chief and Council President. M. McGinley said you need to call 911 every time he makes you feel uncomfortable. Mr. Flynn said he has, and the cops don't help.

President Collins stated that we have done everything to move this through the court, but our hands are tied at the moment and can only do so much.
