L. Pinto- any traction on parking permits? Tutak stated that this is being brought up on Tuesday to the finance committee. There might be an issue with age discrimination.

R. Guerra- Chicken Coop on Burke Ave- Ordinance. Tutak asked Mr. Zizza to contact him after the last meeting, but he did not reach out. Tutak will contact him this week.

M. Boyce- looking to do a night with the code enforcer. Tutak stated that we have tentative date for May.

## **Public Comment**

Mike Doughtry 315 Burke Ave

He wants to thank the fire and police, as well as the mailman.

Any update on the Clock? Tutak stated that we received the footing information. You should see within the next week or so with the old one being removed. The clock is still being fabricated. Anything new with Taylor Hospital? D. Collins stated we are still waiting on more contact from them.

#### Mike Gale 51 Collier Circle

He is confused on this Prospect tax settlement. He attended the school board meeting, where they discussed a settlement. D. Collins, stated that you are aware that the school district is free to go into their own agreement, we are working through this with our attorneys. Mike believes that they are negotiating on behalf of Borough. L. Pinto stated Council has seen this, but we cannot comment as a Borough since this is in negotiations with attorneys. Mike read numbers about what the assessment would go down to. Mike stated that this was approved at the last school board meeting.

Mike is asking that Council look at this settlement. He believes it's a bad deal. In 2023 the hospital was sold for \$46.1 million dollars.

D. Collins stated that we are looking at this deal, which is why we haven't settled. There is communication between Council and the solicitors. The solicitor in this room, did not share those numbers with us. Our attorney's job is to provide the correct information. The numbers that Mike shared are not what was presented to us.

### Andy Furman 419 Pomeroy Street

The settlement that the school board has already approved doesn't mean the Borough is going to approve it. He has never heard of a settlement being different for the school, municipality. He has a copy of the solicitor's report from the school board meeting. Andy believes that the school district solicitors need to be working with the solicitors for Ridley Park. This is a bad deal. There was a sale last year for \$46 million, yet what they agreed to was \$21 million, but then gets reduced to \$14 million. Andy believes that the baseline should be \$205, we shouldn't be reducing their tax assessment. Andy stated that this is 41-44% less than what they have paid in the past.

Marcus 410 Tome Street

Will they be submitting an independent report? D. Collins stated yes, this will be a public report. He also mentioned that he is in favor of the chicken coops. He stated that there are websites that can guide the legislation for chickens in municipalities.
