The Wednesday night Code Enforcement meeting was outstanding. It was very informative. Mike asked if we received any money from the speed counter? Chief said no, it was just a counter, we will be placing a officer there for enforcement.

### Sandy Hess 317 Burke Ave-

Like Mike, Sandy wanted to thank Rich for setting up the Code Enforcement meeting. Ryan McCann did a great job and she hopes he continues to.

The clock is going back up? When? Guerra said we are working with our contractor. Two or three months? Guerra said no, not that long we are waiting for the contractor. Sandy wanted to know why the old one was taken down so early. Tutak said a lot of prep work needed to be done. Sandy wants to know if there is an update for microphones. Tutak said that the microphones we were looking at are for digital not for council chambers.

### Mike Gale 51 Collier Circle

Is there any update on the Prospect settlement? The solicitor said there is no update. Gale mentioned that the appeal goes back to 2020. Mike believes the school made a settlement. Mike is worried the hospital will go bankrupt prior to reaching any settlement. Mike said that nothing has been mentioned since last year.

The Ridley School Board 2024-2025 budget looks like the largest tax increase ever. Unfortunately, Ridley Park is going to be hit with a huge tax hike.

Andy Furman 419 Pomeroy Street

Last month, the 2022 Audit was completed. Andy has a few questions, the was a deficit of \$142k, the fund balance went down.

Is there any time frame for the 2023 audit? Tutak There is a mid-June completion date.

The finance numbers tonight was high, what is in that? Tutak mentioned that the expenses include payroll, insurance, etc.

The Verizon franchise agreement, will this number change at all? Tutak mentioned that this number has changed due to cable.

The prospect tax, what happens if the Borough doesn't accept the agreement? The Solicitor mentioned that each entity can move on their own and neither supersedes.
